Subject: ORDER TO MODIFY LICENSE AND TERMINATE SHOW CAUSE ORDER  
 DATED DECEMBER 8, 1980

By EN-80-53, dated December 8, 1980, the Commission was informed that IE had issued to Applied Health Physics, Incorporated an Order to Modify License (Effectively Immediately) and Order to Show Cause Why Such Modification Should Not Be Made Permanent. This action was based on the licensee's failure to transfer all waste byproduct material to an authorized land burial facility as required by an order issued July 2, 1980. After evaluation of the licensee's written response (dated January 27, 1981) to the December 8, 1980 Order, the Staff determined that the licensee's proposed actions were such that future activities involving licensed material could be conducted in compliance with the Commission's requirements. This is to inform the Commission that IE has issued to the licensee today an Order to Modify License No. 37-14600-01 to incorporate as requirements the licensee's statements in its letter dated January 27, 1981 and to terminate the Order to Show Cause dated December 8, 1980. A news release has been prepared and will be issued about the time the licensee receives the Order. The licensee and the Commonwealth of Pennsylvania are being informed by telephone.

Under the terms of the Order, any person who has an interest affected by the license modification may request a hearing within 25 days of the date of the Order.
