Enclosed are the *Early Site Permit Demonstration Program -- Plant Parameters Envelope Report*, and the *Early Site Permit Demonstration Program -- Siting Guide: Site Selection and Evaluation Criteria for an Early Site Permit Application*. The Plant Parameters Envelope (PPE) report contains information based on the four Advanced Light Water Reactor (ALWR) designs. It is intended as an industry tool to assist an applicant in site safety and environmental suitability determinations required by NRC regulations when actual plant information is not available, e.g., the Early Site Permit (ESP) applicant may not have contracted with a plant vendor to purchase a specific ALWR design. The Site Selection and Evaluation Criteria (SSEC) guide is also an industry tool that is available to an applicant for use as a systematic and comprehensive site selection process.
