Dear Mr. Resnick:

I am writing in partial response to your letter dated January 8, 1992, in which you appealed Mr. Donnie H. Grimsley's response to your Freedom of Information Act request. Mr. Grimsley's response denied all records subject to your request for copies of records supporting a synopsis of alleged violations relating to your client, the University of Cincinnati, and any referral of the matter by the U.S. Nuclear Regulatory Commission (NRC) to the Department of Justice.

Acting on your appeal, I have carefully reviewed the record in this case and have determined that certain information can now be made publicly available. Your appeal is, therefore, partially granted.

The records identified on the enclosed Appendix A can now be made publicly available and are enclosed. Appendix A previously listed 15 records, 11 of which you indicated you did not wish to receive. Accordingly, Appendix A now lists only the four records you indicated you wished to receive in your telephone conversations with Ms. Sarah Wigginton on June 15 and 16, 1992. The record identified on the enclosed Appendix C has already been made available for public inspection and copying in the NRC Public Document Room (PDR). Enclosed is information on how you may obtain access to, and the copying charges for, records located at the PDR.

The review of the disclosable portions of Appendix B records, which will be identified in a later response to you, is still ongoing. You will be notified upon completion of this review.
