REPORT FOR THE ENERGY FUELS NUCLEAR'S HANKSVILLE  
ORE BUYING STATION - JULY 1, 1984 THROUGH  
DECEMBER 31, 1984

By letter dated April 10, 1985, Energy Fuels Nuclear, Inc. (EFN) submitted an environmental monitoring report for the period July 1, 1984 through December 31, 1984, in compliance with 10 CFR 40.65 and License Condition No. 30 (SUA-1325). This memorandum presents the URFO staff review of this data with respect to past data and applicable standards.

The Hanksville ore buying station (HBS) has not operated as a buying station for several years, and all stockpiled ore was removed by March 31, 1982.

During June 1984, extensive decommissioning efforts commenced at HBS (see memorandum to Docket File No. 40-8675, dated April 5, 1985).

Air Monitoring

My review of the data indicates that the locations, parameters, frequencies and sensitivities were as required by License Condition No. 30. All data was less than 0.01 percent MPC for natural uranium.

Direct Radiation

My review of the data indicates that the locations, parameters, frequency and sensitivity were as required by License Condition No. 30. All exposures were less than 50 percent of MPC and showed a significant decrease compared to previous values.
