Subject: DEMAND FOR INFORMATION

This is to inform the Commission that a Demand for Information (Demand) will be issued today to Cameo Diagnostics Centre, Inc. This action is based upon the licensee's use of NRC-licensed material at a location that was not authorized in its license; the licensee's refusal to voluntarily discontinue unauthorized use of these materials; and the licensee's failure to inform the NRC of this use after being specifically informed in a letter dated November 13, 1992, that the licensee did not have authorization to use these materials at this new location.

As further described in the Demand, the information that is known about the circumstances of this case cast doubt on whether the Licensee's President, Mr. Rosenbaum, will provide complete and accurate information, communicate with the NRC in a forthright and candid manner, and conduct operations in accordance with regulatory requirements. The Demand is being issued to determine whether the NRC has reasonable assurance that, in the future, the licensee and its President will provide complete and accurate information to the NRC and otherwise conduct licensed activities in accordance with the Commission's requirements.

It should be noted that the licensee has not been specifically informed of the enforcement action. The schedule of issuance and notification is:

Mailing of Notice	December 17, 1992
Telephone Notification of Licensee	December 17, 1992

The State of Massachusetts will be notified.

The licensee has thirty days from the date of the Demand in which to respond. Following NRC evaluation of the response, the staff will determine whether the License should be modified, suspended, or revoked or other enforcement action taken to ensure compliance with NRC regulatory requirements.
