R.L. ANTHONY/FOE PROPOSED FINDINGS AND CONCLUSIONS ON EMERGENCY PLANNING CONTENTIONS FOR
GRATERFORD PRISON INMATES

CONCLUSION As an intervenor in the Limerick licensing process with contentions on emergency planning, R.L. Anthony/FOE assert our direct involvement with the emergency plans for Graterford inmates, and we find as the outcome of the hearings before the Board on the contentions admitted, and because of the failure of the Board to admit other inmates' contentions vital to their safety, and the safety of all the other occupants of the EPZ that the emergency plans for Graterford are not adequate nor able to be implemented. These plans are in violation of NRC regulations and FEMA as shown below.

Graterford emergency evacuation plans are intimately interrelated with emergency plans for the whole EPZ and these plans are not adequate and not able to be implemented, starting from the boundaries of the EPZ which were not set up with FEMA consultation as required, as shown in our submissions cited below.

In addition to the flaws in offsite emergency planning are the flaws in PECO plant, personnel, and operating procedures at the plant itself which make the safe operation of Unit 1 impossible at this time as shown below.

Consequently we find that the Graterford inmates prevail in their contentions and that the emergency plans in their present form are inadequate and not able to be implemented, and hence NRC and FEMA requirements have not been satisfied and the Board cannot authorize the issuance of a full power license.
