SUBJECT: ITEMS OF INTEREST

#### KERR MCGEE CORPORATION

On June 21, 1985, representatives of Kerr-McGee Corporation met with representatives of NMSS to discuss the additional environmental information being supplied in response to NRC questions on the  $UF_6$  to  $UF_4$  conversion amendment request. Copies of the response were supplied to NMSS at the meeting. During the course of discussions, a number of other topics were discussed including the hearing request of the  $UF_6$  to  $UF_4$  amendment, the comprehensive waste disposal amendment, and the license renewal.

#### NUCLEAR FUEL SERVICES

On June 20, 1985, a meeting was held in the Willste Building among NMSS, Region II, and NFS. The meeting was requested by NFS to present a plan for starting up additional operations using salaried personnel.

#### NUCLEAR FUEL SERVICES

On June 21, 1985, a meeting similar to one mentioned above, was held with representatives of the Oil, Chemical and Atomic Workers Union (OCAW). These officials represented the striking workers at NFS. The meeting was requested by the OCAW so they could present their reasons why the staff should not allow NFS to restart production operations.

#### NMSS RADIOLOGICAL EMERGENCY RESPONSE

The NMSS Radiological Emergency Response Manual was revised to reflect procedural changes resulting from the move of the NRC Operations Center. Copies of the
