This letter refers to the physical security inspection conducted by Mr. G. C. Smith of this office on January 25-28, 1993, of activities authorized by NRC License No. DPR-50 at Three Mile Island (TMI) Unit 1, Middletown, Pennsylvania and to the discussions of findings held with Mr. M. Ross and other members of your staff by Mr. Smith at the conclusion of the inspection.

Areas examined during this inspection are important to public health and safety and are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel and observations by the inspector.

We found that the physical security program being implemented at TMI was directed toward the protection of public health and safety. Within the scope of this inspection, no safety concerns or violations of regulatory requirements were identified.
