Gentlemen:

Please find enclosed our application in triplicate for license to export slightly enriched UF₆. This material will be used for the fabrication of fuel assemblies and ultimately loaded into the Mihama Nuclear Power Plant Number 1 owned by The Kansai Electric Power Co., Inc.

The contract number for the uranium enriching services with the U.S. Department of Energy is E(49-14)UES/JA-27.

The feed material is supplied from the United Kingdom.

The relevant enriched UF₆ will be delivered at the U.S. D.O.E. Oak Ridge Enrichment Plant in Oak Ridge, TN. After being exported to Japan, it will be converted to UO₂ powder, pelletized and fabricated into fuel assemblies by Mitsubishi Nuclear Fuel Ltd.


As the validity of the export license, we wish to have a two year period from the date of issuance.

With regard to sampling, we request that two (2) P-10 tube samples be taken from each parent cylinder. These samples should be delivered to us c/o Teledyne Isotopes for independent analysis. We also request that the Nuclear Audit and Testing Company witness the weighing and sampling.
