Dear Mr. Grimsley:

On June 17, 1992, I submitted a Freedom of Information Act ("FOIA") request which has been designated by the Nuclear Regulatory Commission ("NRC") as FOIA No. 92-297 (copy attached). At this time, I wish to amend the first two paragraphs of FOIA No. 92-297 to read as follows:

I hereby request, pursuant to the federal Freedom of Information Act ("FOIA"), 5 U.S.C. 552, as amended, and Nuclear Regulatory Commission ("NRC") regulations, 10 C.F.R. Part 9, copies of all "records" as defined in 10 C.F.R. 9.13 constituting or relating to the original notes taken by the employees and representatives of the NRC who investigated the March 20, 1992 site area emergency at Plant Vogtle during the period March 20, 1990 through June 8, 1990. The individuals who may have records subject to the foregoing request include, but are not limited to, NRC Region II employees and representatives and the members of the Augmented Inspection Team ("AIT") and the Incident Investigation Team ("IIT") which were sent to Plant Vogtle shortly after the March 20, 1990 event.

For your information, I understand that the records subject to the foregoing request are or may be in the possession of the following NRC personnel, among others: (1) NRC Region II personnel - Ken Brockman, Eldan Testa and Milton Hunt; (2) the AIT members - Ken Brockman, Lee Trocine, Ken Clark and Eldan Testa; and (3) the administrative assistant to the IIT, Ms. Cherie Siegel, and the IIT members - Al Chaffee, Rick Kendall, Bill Lazarus, Bill Jones, Mike Jones, Warren


