

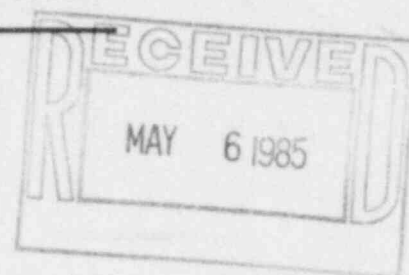

Dear Mr. Cain,

We recently made an amendment on the above mentioned license regarding an address change for our company. (Your control Number 18743) - me 21

After a recent inspection by U.S. Radiation Specialist Charles A. Hooker, he suggested that we also needed to make the following amendments:

1) Company Name Change - Jetco Wireline (Montana), Inc. has merged with Magnum Jet, Inc. and NC Wireline. Therefore, we would like the new license to read Magnum Jet, Inc. and NC Wireline, (an assumed business name.) I have enclosed a copy of our Certificate of Registration from the State of Montana to show that NC Wireline is an assumed business name under Magnum Jet, Inc.

2) Source Model Number Change - We no longer own Sealed Source Numec Model AM-93. This source was transferred back to Jetco Logging Service, License#25-10912-01. We had informed you in writing at that time of transfer.

On December 19, 1984 we purchased Americium 241 Sealed Source (3 curies) Model No. NEEI 71-1. Serial No. 71-1-147.

3) Barrie G. Ibsen, who was listed on our previous license under Condition 12 is no longer employed with our company. Would you please remove his name from our license. Paul DeKaye is now the only person who should be listed on our license.
