Dear Dr. Cunningham:

This letter is in response to your letter dated January 28, 1993, in which you informed the NRC of additional actions to ensure that all licensed material be placed in a locked, stored, and shielded condition as required by Section VI of the immediately effective Order issued on January 20, 1993.

Based on the information in the letter, it is our understanding that all licensed material will be removed by the manufacturer from the HDR units at the Indiana Cancer Center, The Life Care Cancer Center, The Exton Cancer Center, and the Mahoning Valley Cancer Center. Further, we understand that the HDR units are secure and that the keys to these units are in the possession of the Medical Director of each center.

We have determined that removal of the sources by the manufacturer will ensure the protection of public health and safety at these centers and therefore, authorize you to arrange such removal. Please advise this office in writing when the removal is accomplished at each center.
