SUBJECT: MODIFICATION TO ORDER SUSPENDING LICENSE

Dear Dr. Colkitt:

This refers to our Order Suspending the Above Named License (Order) issued January 20, 1993, to Oncology Services Corporation and to the request for modification of the Order submitted on January 28, 1993, to Mr. Richard Cooper of this office by your Attorney, Kerry A. Kearney. Ms. Kearney requested that authorization be given to allow resumption of treatment for four patients at your licensed facility in Harrisburg, Pennsylvania.

Ms. Kearney informed us in writing that the reason for requesting authorization to resume treatment was the immediate distress of the four patients and the determination by your physician that these patients could be cured if HDR treatment is started immediately. Ms. Kearney also informed us that your physicist, Dr. David Cunningham, is personally present at the Greater Harrisburg Cancer Center for HDR treatments. Subsequently, our inspector, Ihor Czerwinskyj, visited the Greater Harrisburg Cancer Center on February 1, 1993 to verify the information provided by you.

We have evaluated the information you have provided and find good cause is demonstrated for the resumption of treatment for these four patients.

Therefore, in accordance with your January 28, 1993 request, and pursuant to Section VI of the Order, Section VI, paragraph 2 of the Order is amended to read as follows:

The licensee may treat the four patients at the Greater Harrisburg Cancer Center for which relief was requested on January 28, 1993.

All other provisions of the January 20, 1993 Order remain in effect.
