Dear Mr. Hendricks:

I am responding to your return of the Second Notice (Overdue) objecting to the assessment of the FY 1996 annual fee for your Materials License 21-26329-01 (Invoice No. AM5006-96), which we received August 22, 1996. You state that Thomas R. Hendricks, P.E. has terminated License 21-26329-01 and merged with Wilcox Associates.

Footnote 1 of 10 CFR 171.16 provides that the annual fee is waived when a license is terminated prior to October 1 of each fiscal year. The 1996 annual fee is waived for those licensees and holders of certificates, registrations, and approvals who either filed for termination of their licenses or approvals or filed for possession only/storage only licenses prior to October 1, 1995, and permanently ceased licensed activities by September 30, 1995. An amendment request filed after October 1 of each fiscal year to cancel a license does not cancel the annual fee invoice. In addition, 10 CFR 171.17 provides that licenses for which termination requests are filed during the period October 1 through March 31 of the fiscal year are assessed one-half of the annual fee. Your July 22, 1996, termination request was not timely filed for purposes of avoiding the FY 1996 annual fee or for the 50 percent proration. Therefore, Invoice AM5006-96 is due and payable.

Enclosed is an Form 526, Certification of Small Entity Status for FY 1996, for your possible use. If you determine that Thomas R. Hendricks, P.E. meets NRC's lower tier small entity size standards, please complete and return the form. A reduced fee of \$400 would then be due. If Thomas R. Hendricks, P.E. does not qualify as a lower tier small entity the full invoiced amount is due. Payment of the appropriate fee should be mailed, with the completed Form 526, if applicable, to the address listed on the invoice. Late charges will be waived if payment is received within 30 days from the date of this letter. If payment is not received within 30 days, all late charges will be assessed.
