Dear Mr. Kinnerman,

As stated in our recent telephone conversation, NEN Products is planning to move its Chicago Distribution Center from Schiller Park to Des Plaines. Our lease expires on June 30, 1985 at our present location. In order to prevent a disruption of business and service to our customers, we would like written/verbal permission to move the operation during the weekend (June 22 and 23, 1985), and begin distribution from the new facility on Monday, June 24, 1985. (Attached is a copy of the new location discription.

The new location's set-up is very similar to the present facility. It is a single story, multi-tenant, concrete building, and is six years old. We will occupy 1650 square feet and have two sales operations as abutters.

The Radiation Protection Program and Radiation Safety Officer will remain the same in all respects. All requirements under the license and State and Federal regulations will be strictly adhered to as in the past.

We fully understand that in order for the Commission to release the Schiller Park facility from the license and its conditions, an indepth survey is required. This survey would be performed immediately after the move is completed (June 24, 1985). For your information, a representative from Illinois Department of Nuclear Safety will be at the facility on June 24 to observe the close-out survey. A copy of the survey will be sent to your office immediately upon completion. Since there has never been radioactivity processed or opened in this facility, or a contamination incident, no unforeseen difficulties are expected.

Please review the above, and I will call you the week of June 17, 1985 to discuss the details. Your attention in this matter is most appreciated.

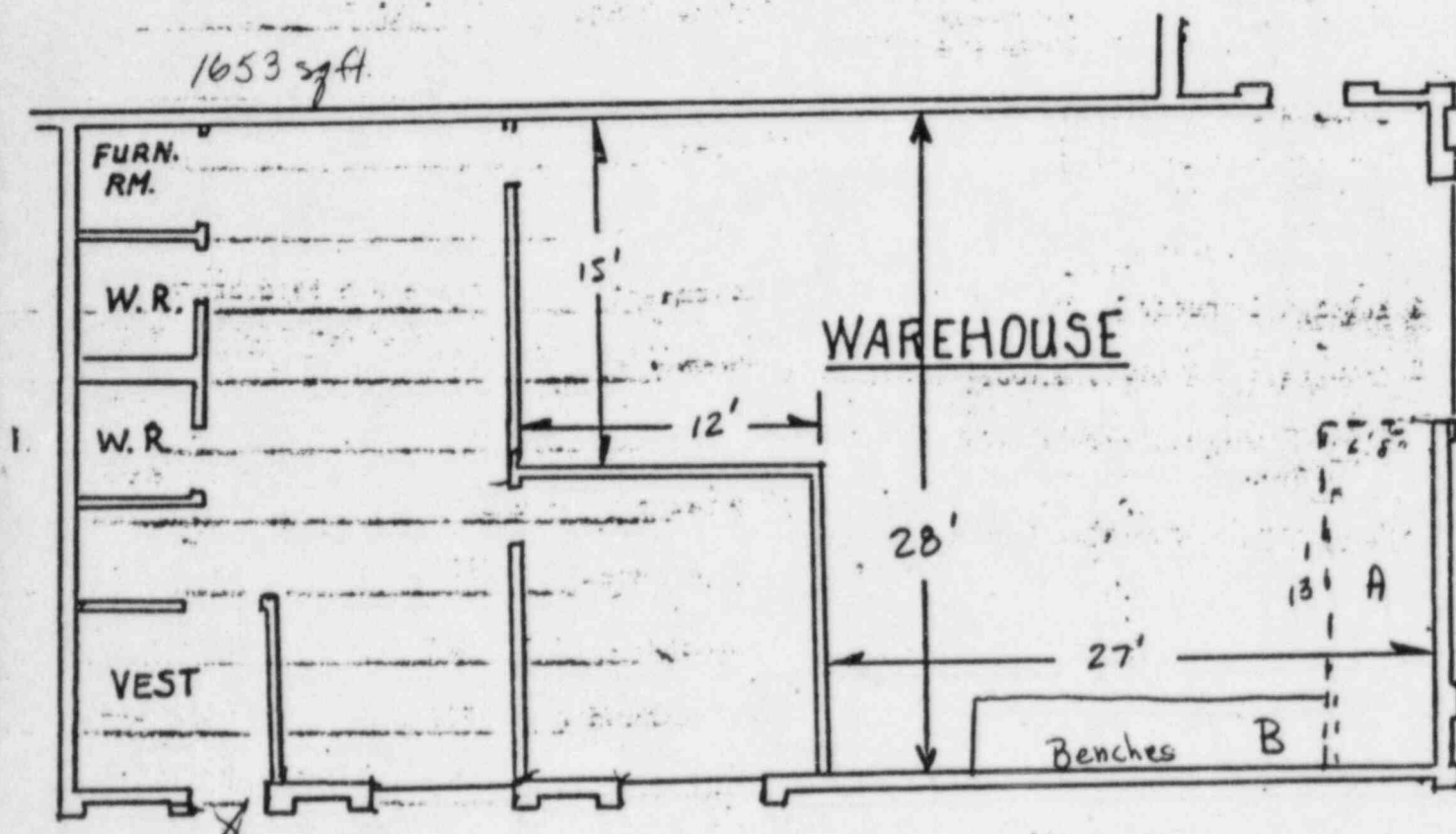
