1.0 A STATEMENT REGARDING OUR CURRENT PROGRAM

The Columbia Regional Hospital, of Columbia Missouri does wish to renew this license for the use of radioactive materials. A detailed review of the license, and related amendments and documentation, has revealed no discrepancies between this documentation and our operating procedures, personnel (with exceptions defined in section 2.0 of this application), and facilities.

We intend to continue operation in accordance with this licensing documentation including:
"statements, representations,, and procedures contained in applications dated September 27, 1979 and August 7, 1980; application received July 16, 1982; letters dated January 17, 1980, February 2, 1982 (with attached letters dated February 9, 1982, November 3, 1981, signed by A. H. Emmons); February 7, 1984, agreement dated January 20, 1984, signed by David Finkel and letter dated April 27, 1984, and the ALARA Program as contained in Appendix O of Regulatory Guide 10.8, October, 1980."

We understand and accept that the Nuclear Regulatory Commission's regulations shall govern this licensee's statements in applications or letters, unless the statements are more restrictive than the regulations.

2.0 REQUESTED CHANGES IN AUTHORIZED USERS

Our last request for license amendment was submitted in the form of a letter dated June 19th, 1984. Amendment Number 12 was issued in response to that request. Amendment 12 altered Condition 12, the listing of authorized users and the materials and uses for which each individual was licensed. We wish to change that list of authorized users. All of our changes are deletions from that list and so require no supporting documentation.
