Dear Mr. Bracken:

I am responding to your note submitted on your returned Invoice No. AM4573-96 dated June 11, 1996, for License No. 37-19357-01. Your note states that the license is not being renewed; Bracken Construction Company is out of business and the devices have been transferred to IA Construction Corporation.

Footnote 1 of 10 CFR 171.16 provides that the annual fee is waived when a license is terminated prior to October 1 of each fiscal year. The 1996 annual fee is waived for those licensees and holders of certificates, registrations, and approvals who either filed for termination of their licenses or approvals or filed for possession only/storage only licenses prior to October 1, 1995, and permanently ceased licensed activities by September 30, 1995. An amendment request filed after October 1 of each fiscal year to cancel a license does not cancel the annual fee invoice. Your termination request was not timely filed for purposes of avoiding the FY 1996 annual fee. License No. 37-19357-01 was terminated on November 28, 1995, based on your October 2, and November 22, 1995, letters and facsimile dated October 30, 1995.

As provided in 10 CFR 171.17, licenses for which termination requests are filed during the period October 1 through March 31 of the fiscal year are assessed one-half of the annual fee. Your termination request was timely filed for purposes of the 50 percent proration. As stated in the invoice, the amount billed reflects the 50 percent proration. Therefore, Invoice AM4573-96 is due and payable.

Enclosed is an NRC Form 526, Certification of Small Entity Status. If you determine Bracken Construction Company meets NRC's lower-tier small entity size standards and so certify by completing and returning the NRC Form 526 for FY 1996, the annual fee would be reduced. Because the amount billed under Invoice AM4573-96 reflects a 50 percent proration of the annual fee, the amount due would be 50 percent of the amount shown on NRC Form 526 for the lower-tier size standard under which Bracken Construction Company qualifies for each fee category reflected on the invoice. Payment of the reduced fee should be sent with the completed NRC Form 526 to the address listed on the invoice. If Bracken Construction Company does not qualify for a lower-tier small entity, the full invoiced amount is due. Late charges that have accrued will be waived if payment of the \$800 annual fee is received within 30 days from the date of this letter. If payment is not received in 30 days, all late charges will be assessed.
