This refers to the inspections conducted by John Jones of the NRC's Region III office on August 28, 1996. The inspections included a review of activities authorized for the Great Lakes Service School, Great Lakes, Illinois (Navy Radioactive Material Permits 12-0580A-AINP[Report No. 96-10] and 12-0580A-CINP[Report No. 96-11]), under your license. At the conclusion of the inspection, the findings were discussed with LCDR Hallowell, Hull Division Officer and LT J. E. Norton, Director of Electronics.

Each inspection was an examination of activities conducted under your license with respect to radiation safety and compliance with NRC regulations and the conditions of your license. It included selective examinations of procedures and representative records, interviews with personnel, and direct observations by the inspector.

As indicated in the enclosed NRC Form 591 (Safety Inspection) documents, no violations of NRC requirements were identified. Accordingly, no response to this letter is required.
