Dear Mr. Keppler,

In my March 7, 1985 letter to you I stated that Nuclear Pharmacy, Inc. (NPI) had requested that Hydro Nuclear Services (HNS) include an evaluation of the NPI audit program in their next audits. As documented in Dr. Gallina's April 12, 1985 letter, this evaluation has been completed. The results of this evaluation are stated in Dr. Gallina's summary that "NPI operations, in conjunction with its internal audit program, have progressed to such a level that NPI has a firm and substantial basis for requesting,...., that the NRC Order Modifying Licenses be lifted in its entirety."

We are, therefore, formally requesting that the NRC Order Modifying Licenses be lifted in its entirety. If you feel that this request is premature or the scope too broad, we would like to meet with you, at your convenience, to discuss our program and what additional steps are necessary to provide you with reasonable assurance that the order can be lifted and that NPI's operations will continue to be conducted in full compliance with NRC requirements.

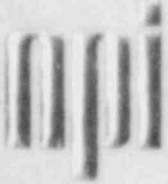
