This is in partial response to your letter dated April 2, 1985, in which you requested, pursuant to the Freedom of Information Act (FOIA), eight categories of records related to E. Earl Kent and his allegations regarding the Midland, Palisades and San Onofre nuclear power plants.

The NRC has previously responded to five FOIA requests for records containing information similar to that identified in your letter. Copies of those requests and NRC's response letters, listed on the enclosed Appendix A, are enclosed.
