This refers to the routine inspection conducted on October 3, 1996, of your facilities which were formerly occupied by Horizons, Inc. located at 2909 East 79th Street, Cleveland, Ohio. Our findings were discussed with you at the conclusion of the inspection.

The inspection was a review of the facility ownership. Limited radiological surveys were also conducted to ascertain the status of the areas in the facility where the NRC had previously identified contamination.

The facility appeared to be well maintained and contaminated areas were adequately identified with ropes and postings, or locked. Enclosed is a copy of our inspection report.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosure will be placed in the NRC Public Document Room.
