Dear Mr. Dawicki:

On September 30, 1996, Eric H. Reber of this office conducted a safety inspection at your facility of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with you, at the conclusion of the inspection.

From the discussion of our findings at the conclusion of the inspection, we understand that you will conduct an investigation to determine the cause of the film badge readings attributed to a specific individual during the past several years and implement corrective actions as appropriate. This individual's film badge results indicated that he received a whole body exposure of 1790 millirem in 1996, and 2720 millirem in 1995. In your reply to this letter, please confirm this understanding and describe those actions taken or planned regarding this issue.

Based on the results of this inspection, it appears that your activities were not conducted in full compliance with NRC requirements. A Notice of Violation is enclosed and categorizes each violation by severity level in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," (Enforcement Policy), NUREG 1600. You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. Your response may reference or include previous docketed correspondence, if the correspondence adequately addresses the required response. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

Please use the enclosed self-addressed green envelope when you respond to this letter to assist us in the timely processing of your response. In accordance with Section 2.790 of NRC's "Rules of Practice," Part 2, Title 10, Code of
