Conditions 10. and 18. are amended to read:

10. Licensed Material may be used at the licensee's facilities located at 4524 East Market, Enid, Oklahoma; Highway 20 East Osage Prue Cutoff Road, Moiny, Oklahoma; Forth and Taylor, Henryetta, Oklahoma; U.S. Highway 70 West of Ardmore, Oklahoma; and at temporary job sites of the licensee anywhere in the United States where the U.S. Nuclear Regulatory Commission maintains jurisdiction for regulating the use of licensed material.
18. Except as specifically provided otherwise by this license, the licensee shall possess and use licensed material described in Items 6, 7, and 8 of this license in accordance with statements, representations, and procedures contained in applications dated November 9, 1979, and February 11, 1981; letters dated June 26, 1980, July 21, 1981, October 20, 1981, December 22, 1981, March 2, 1982, May 18, 1982, March 21, 1983, April 15, 1983, November 30, 1983 (2 letters), January 31, 1984, and May 7, 1985. The Nuclear Regulatory Commission's regulations shall govern the licensee's statements in applications or letters, unless the statements are more restrictive than the regulations.
