This letter is in reference to your letter dated August 6, 1991, which indicated that LFE Industrial Systems Corporation plans to continue to distribute the products listed in the table in Enclosure 1 (column 1 of the table includes the registration certificate number and column 2 includes the model numbers of the products). As discussed with you during our meeting at your facility on July 6, 1995, we are in the process of updating the registration certificates for the products listed in the table. Updating the registration certificates includes reviewing the information submitted to support the evaluation of the products.

In performing the review of the registrations, and the supporting documentation, it was found that the background files are, in most cases, incomplete and/or contain outdated information. Therefore, to support the registration of the products, LFE needs to resubmit complete applications for each product listed in Enclosure 1. The applications should be submitted in accordance with 10 CFR 32.210, Regulatory Guide 10.10 "Guide for the Preparation of Applications for Radiation Safety Evaluation and Registration of Devices Containing Byproduct Material," and Regulatory Guide 10.11 "Guide for the Preparation of Applications for Radiation Safety Evaluation and Registration of Sealed Sources Containing Byproduct Material."
