On August 28, 1996, C. Thor Oberg of this office conducted a safety inspection at Biofor, Inc., Route 632, Olyphant, Pennsylvania of activities authorized by the NRC license listed below. The inspection included observations by the inspector, interviews with personnel, selective examination of records and confirmatory surveys of the Biofor, Inc., (Biofor) facilities at Olyphant, Pennsylvania. A copy of the NRC inspection report is enclosed. The findings of the inspection were discussed with Todd Mobley, AHP Service Representative, at the conclusion of the inspection. This also refers to telephone conversations on August 16 and October 9, 1996, between Mr. Mobley and Mr. Oberg.
