On April 4, 1985, we received a letter from the Nuclear Regulatory Commission regarding a letter sent from our hospital notifying them of our name change to East Ohio Regional Hospital at Martins Ferry. Initially our Consultants from Nuclear Medicine Associates advised us to disregard this. The NRC then sent us another notice saying that our license amendment will be abandoned within thirty days. Our license expires in November of 1985. Our Consultants had hoped that we could combine this item and save the amendment fee. Nuclear Medicine Associates spoke with Cheryl Phillips on Friday, April 19, 1985. She says that we must pay the additional \$120.00. In addition to the check please send a copy of the letter announcing the name change. 

RESOLUTION
