On October 3, 1996, Richard McKinley of this office conducted a safety inspection at the above address of activities authorized by the NRC license listed below. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with Cindy Kane of your staff at the conclusion of the inspection.
