

Pursuant to 10 CFR 50.54(p), please find attached five (5) copies of Revision 8 to the Catawba Nuclear Station Security Plan. Revision 8 generally reflects the wording concerning the random routing of auxiliary feedwater piping and the related changes to Illustrations, Figures and Drawings CSP-10-02, CSP-10-03, CSP-2 and CSP-3. Specific plan changes are addressed in the attachment. Revision 8 does not decrease the effectiveness of the Catawba Nuclear Station Security Plan.
