Dear Congressman Snyder:

I am pleased to respond to your letter dated May 22, 1981 in which you forwarded a letter from one of your constituents concerning resumption of concrete work at the Marble Hill Nuclear Power Station construction site.

I can assure you that the decision to authorize concrete placement was made only after a thorough review of the improvements made in the construction quality assurance program and after verification of the structural adequacy of the existing concrete. The verification program consisted of extensive testing and examination of the concrete by Public Service of Indiana and its consultants, review of test findings made during the actual concrete placement, and a review of previous NRC inspection findings. In addition, NRC adopted a suggestion from Save the Valley, an area environmental group, that outside consultants review the concrete work to provide additional assurance to area residents.

NRC retained two civil engineering experts, Alfred Parme and Rolland Hamm, to review the work. In addition, Save the Valley's consultant, Professor Michael Cassaro, was permitted to accompany the NRC consultants and to have access to the same information as the consultants. It was never the intent that the decision on resumption of concrete work would depend on submittal of a final report from the two NRC consultants. NRC planned to, and in fact did confer with the NRC consultants prior to permitting resumption of safety-related concrete work. The consultants verbally reported that they had concluded that the existing concrete was structurally sound. This finding will be documented in a final report, which will also include a review of the repairs of surface defects that could not be undertaken until work resumed at the site.

Professor Cassaro questioned the adequacy of one portion of the construction verification program, the "ultrasonic" testing of sample areas of concrete. His view is that the number of sample areas did not meet the NRC's previously established statistical criteria for the testing. Our review of the testing program, however, determined that the sample testing did meet the criteria and was sufficient to determine that there are no significant internal defects in the concrete. In addition, at the request of the two NRC consultants, portions of concrete were cut out of various locations in the plant and tested. The test results further confirmed the adequacy of the concrete.

In conclusion, I can assure you that the U.S. Nuclear Regulatory Commission is most concerned that the Marble Hill plant be built in accordance with the appropriate standards and regulations. When significant problems were found

The decision to permit resumption of concrete work at Marble Hill was made only after extensive inspection of work at the site and review and evaluation of the upgraded management and quality assurance programs, as well as soliciting the findings of the consultants.

When the consultants' report is completed, within about one month, it will be publicly available. NRC documents on Marble Hill are available for inspection and copying at the Madison-Jefferson County Public Library in Madison, Indiana. Included in the documents available are Professor Cassaro's letters to NRC on the sampling program and NRC's replies.

I trust this information satisfies your concerns and those of your constituents.
