The purpose of this modification is to provide incremental funding in the amount of \$425,000.00 which increases the obligated amount from \$1,138,000 to \$1,563,000.00. Accordingly, the following change is hereby made:

1. Under Section B, Items (b) and (c), "CONSIDERATION AND OBLIGATION--COST REIMBURSEMENT (JUNE 1988) - ALTERNATE I (JUNE 1988)" is hereby revised to read as follows:

"b. The amount obligated by the Government with respect to this contract is \$1,563,000.00.

c. It is estimated that the amount currently allotted will cover performance through 12/31/97."

All other terms and conditions under this contract, including the ceiling amount of \$2,616,248.00 remains unchanged.
