Dear Dr. Smith;

I am returning an amendment request dated June 9, 1981, signed by R. E. Nohe, from the Edith Nourse Rogers Memorial Veterans Hospital, License No. 20-10184-01.

Individuals who wish to be named as authorized users of materials similar to those listed in 10 CFR 33.11(c) should meet the criteria established in 10 CFR 33.15(b), enclosed. Note that this criteria includes at least forty hours of formal, didactic training.

We cannot credit hours that consist of working "on-the-job" unless a formal on-the-job training program actually existed. If so, you should submit the details of the program (course outline or syllabus, overall grade, or score, certificate of successful completion, etc.).

Dr. Ullman should either submit documentation of additional didactic training or perform his isotope studies under the supervision of an individual who is already named on the hospital license.

Your assistance in the initial screening of application such as this one is necessary at this time. Our staffing manpower is severely limited and the processing of each incomplete application takes much valuable time.
