Dear Ms. Satern:

This is in further response to your letter of March 15, 1985, in which you requested, pursuant to the Freedom of Information Act (FOIA), seven categories of records relating to contracts between the NRC and Binder, Elster, Mendelson, and Wheeler, Inc. (BEMW)

The records identified on the enclosed Appendix A are now available for public inspection and copying at the NRC Public Document Room (PDR) in folder FOIA-85-182 under your name.

As noted previously in my letter to you dated April 8, 1985, regarding all documents you requested under category five, the NRC routinely makes contracts and their modifications available in the PDR.

With regard to category three of your request, you agreed in a telephone conversation with David L. Meyer of my staff on April 22, 1985, to accept a nonproprietary version of each of the requested technical proposals. As noted in my earlier letter to you, the NRC has already made available in the PDR a nonproprietary version of the successful proposal submitted by BEMW under Contract No. NRC-10-82-358 in response to FOIA-82-113. This document is filed in PDR folder FOIA-82-113 under the name H. Milton Smith.

The staff is continuing to review additional records subject to your request. However, prior to completion of your FOIA request, we ask that you submit payment for fees for the professional search time incurred by the NRC staff on your request. As noted in my previous letter to you, a charge of \$12.00 per hour is assessed for professional search time, in accordance with 10 CFR 9.14 of the Commission's regulations. In a telephone conversation on April 15, 1985, between you and David Meyer, he informed you that the staff expended 12 hours of professional search time on your request and you agreed to pay the costs involved. Please send a check made payable to the U. S. Nuclear Regulatory Commission in the amount of \$144.00, along with a copy of this letter, to the Director, Division of Accounting and Finance, Room MNBB-11104, U. S. Nuclear Regulatory Commission, Washington, DC 20555.


