The Contractor shall furnish office space as required for the counseling sessions beginning June 2, 1980 and ending September 16, 1980, at a fixed rate of \$200 per month." 2. The total amount obligated under this contract is increased by \$900.00 from \$16,182.00 to \$17,082.00. 3. Your attention is directed to Clause No. 2 to the General Provisions of the Contract entitled "Changes". Please note that any claim by the Contractor for adjustment under this clause must be asserted within 30 days from the date of receipt by the Contractor of the modification of change.
