The purpose of this modification is to extend the period of performance at no additional cost to the NRC in accordance with the contractor's letter dated November 4, 1996 (ATTACHMENT 1) received 11/25/96. Accordingly, the following changes are hereby made:

1. Section F.5, "DURATION OF CONTRACT PERIOD," is deleted in its entirety and the following is substituted in lieu thereof:
