The purpose of this modification is to extend the Agreement period of performance for one year on a no-cost basis. Therefore, the parties agree to the following:

A. Article II - Period of Performance is revised to delete the date "September 30, 1985" and substitute the date "September 30, 1986" in lieu thereof.

B. The above change shall have no impact on the total estimated cost of the Agreement which is \$999,000.00, nor on the total amount obligated which remains at \$950,000.00.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
