An additional item is that Duke plans to complete all identified HED modifications by the end of the fourth refueling outage for units 1 and 2, as outlined in the implementation schedule enclosed in your May 3, 1985, letter to Harold R. Denton.

If your understanding of the July 1, 1985, conversation is different, please inform the Region II staff as soon as possible.
