TRIBAL COUNCIL TO MEMORANDUM AND ORDER

On September 27, 1985, the Honorable John H. Frye, Administrative Judge in the above captioned proceeding, issued a Memorandum and Order concerning the pending Petitions for Intervention filed by the various parties herein. Said Order provided that the Cherokee Nation and Cherokee Tribal Council could participate as a party "on condition that it consolidate its participation with NACE." (Order, P.4) In response thereto, the Cherokee Nation and Cherokee Tribal Council decline to consolidate its participation with NACE and therefore, withdraw its Petition for Intervention.
