Dear Ms. Wallace:

This is in response to our receipt of the returned delinquent notices and your applications for termination dated August 23, 1996, for License Nos. 45-25060-02G (AM4658-96), 45-25060-01 (AM4667-96), and NR0794D101B (AM0717-96). The applications were forwarded to the Region II office and to Steve Baggett of the Sealed Source and Device Evaluation Branch.

Footnote 1 of 10 CFR 171.16 provides that the annual fee is waived when a license is terminated prior to October 1 of each fiscal year. The 1996 annual fee is waived for licensees and holders of certificates, registrations, and approvals who either filed for termination of their licenses or approvals or filed for possession only/storage only licenses prior to October 1, 1995. An amendment request filed after October 1 of each fiscal year to cancel a license does not cancel the annual fee invoice.

Your August 23, 1996, termination requests for License Nos. 45-25060-01, 45-25060-02 and NR0791D101B were not timely filed for purposes of avoiding the FY 1996 annual fees. Based on recent discussions with Sandra Kimberley of my staff, small entity forms were faxed to us and you stated that payment for the invoices would be forthcoming. Also, you were informed that your first filing for termination on January 18, 1996, was voided and that activities from your licenses did not cease--therefore, your annual fee invoices were corrected to reflect the full amount due rather than the prorated amount. Further, you submitted a new termination request dated August 23, 1996, for all licenses.

We note you received annual fee Invoice AM0670-97 for License No. NR0794D101B and AM0207-97 for License 45-25060-02G. Your August 23, 1996, request for inactivation of the registration and license is considered timely filed to avoid the FY 1997 annual fee. Therefore, Invoice AM0670-97 and AM0207-97 have been cancelled.

We acknowledge the receipt of payments for Invoice Nos. AM4658-96, AM4667-97, and AM0717-96, and all are considered paid-in-full. Thank you for your cooperation in this matter.
