## PRIVACY ACT STATEMENT

The information may also be disclosed to appropriate Federal, State, and local agencies in the event that the information indicates a violation or potential violation of law and in the course of an administrative or judicial proceeding. In addition, this information may be transferred to an appropriate Federal, State, or local agency to the extent relevant and necessary for an NRC decision or to an appropriate Federal agency to the extent relevant and necessary for that agency's decision about you.

We will also perform a leak test with Hewlett-Packard No. 18713-60050 leak test kit at 6-month intervals. In case of failure of the leak test the detector will go out of service until repaired by Hewlett Packard. If the detector ever needs cleaning, we will return it to the supplier, Hewlett-Packard Company, Route 41, Avondale, PA 19311. Each operator will be familiar with the instruction manual and adhere to the operating and safety sections of the manual.
