As we have discussed by telephone on August 12 and 16, 1985, Lone Star Industries, Inc. is still in the process of drafting new individual site licenses and confirming the current status and location of the sealed sources of byproduct material identified in License No. 41-16010-02. The license has an expiration date of September 30, 1985, which date would allow us insufficient time to obtain and process all necessary information for the individual new license applications. In light of this, we hereby request an extension of the existing license expiration date from September 30, 1985, to and including December 31, 1985.
