At the present time, we do not wish to renew the current materials licence (NRC #06-09522-03) as issued to Greenwich Hospital Association for the possession and use of nuclear powered pacemakers powered with Pm-147.

The last nuclear powered pacemaker was removed approx. 1 - 1½ years ago and was returned to the manufacturer as required by NRC regulations.

After careful review, it was determined that all installed pacemakers have been retrieved over the years and that there is no future demand for the use of these nuclear powered pacemakers.
