This transmits the Examination Report of Operator Licensing Examinations conducted by USNRC Region I at the Millstone 3 Nuclear Power Station the weeks of May 13 and May 20, 1985. At the exit interview held on May 23, 1985, the preliminary results of these examinations were discussed. Nearly one half of the candidates exhibited an inability to properly diagnose incidents and take the proper corrective actions. At a management meeting held in Region I on July 8, 1985, the results of the examination were discussed and are documented in Meeting Report 50-423/85-40.
