The purpose of this modification is: (1) to amend the key personnel under Section H.1, NRCAR 2025.215-70 KEY PERSONNEL (JAN 1993) to reflect the deletion of Mr. Geoffrey Smith and the addition of Mr. Victor Garaycochea per Contractor's letter dated October 31, 1996, and (2) correct page number 1, item 15G of Standard Form 26 with an effective date of November 16, 1996, to reflect the correct contract amount.

Accordingly, the contract is hereby modified to read as follows:

1. Under Section H.1, NRCAR 2025.215-70 KEY PERSONNEL (JAN 1993), paragraph (a) is deleted in its entirety and the following is substituted in lieu thereof:

- a. The following individuals are considered to be essential to the successful performance of the work hereunder:

Victor Garaycochea - Program Manager  
Ileana Jovel - Backup Program Manager

The Contractor agrees that such personnel shall not be removed from the contract work or replaced without compliance with paragraphs (b) and (c) of this section.

2. Under Standard Form 26, page number 1 item 15G (Total Amount of Contract) is revised from \$0.00 to \$674,704.65.

This is a no cost contract to the Government, therefore this modification does not obligate funds.
