This letter refers to the routine Safeguards inspection of your activity at Palo Verde Nuclear Generating Station (PVNGS), Unit 1, by Mr. D. Schaefer of this office on July 22-26, 1985. It also refers to the discussion of our inspection findings with Mr. Joe Bynum, Plant Manager and members of his staff on July 26, 1985

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and records, interviews with facility personnel and observations by the inspector.
