SUBJECT: SUPPLEMENT I TO NUREG-0737, REQUEST FOR EXTENSION OF TIME FOR
COMPLIANCE WITH COMMISSION ORDER DATED JUNE 14, 1984.

By letter dated January 7, 1985, Philadelphia Electric Company (PECo) requested an extension of the completion date for one item contained in the Commission Order dated June 14, 1984. This request to extend the completion date for submittal of the Detailed Control Room Design Review (DCRDR) Summary Report from March 15, 1985 to June 30, 1985 was granted by the Commission by letter dated February 11, 1985.

On May 22, 1985, you requested a further extension in the DCRDR Summary Report submittal date based upon the availability of operationally experienced Peach Bottom personnel essential to the DCRDR review. Your letter indicated that the recent loss of two senior licensed operators together with the Unit 3 refueling outage and its increased work load demands has resulted in only limited participation in the DCRDR review by key operational personnel. In order to accommodate this unexpected reduced level of effort by operator personnel in the DCRDR review, PECO requested in its May 22, 1985 letter an extension to the DCRDR Summary Report submittal date from June 30, 1985 to February 28, 1986. In this letter, PECO further states that this schedule change is not expected to extend the completion date for the control room enhancement program as a result of the Peach Bottom DCRDR review. The earliest possible date for commencement of the DCRDR enhancement process would be the Unit 2 refueling outage scheduled for late 1986.

We have reviewed your request and conclude that the requested schedular change is acceptable based upon your statement that the requested delay in submittal of the Summary Report is not expected to affect the completion of the currently scheduled DCRDR enhancement program.

Therefore, in accordance with section IV of the June 14, 1984 Commission Order, we conclude that there is adequate cause for extension of time under
