Gentlemen:

By letter dated June 26, 1985, the Nuclear Regulatory Commission withdrew Amendment No. 28 to your Source Material License SUA-1358 dated April 24, 1985. We stated that this was in response to some licensees' assertions that the amendment was invalid on procedural grounds. We further indicated our intent was to reissue the license condition shortly in a manner which clearly removed any question of NRC adherence to appropriate procedural requirements.

Accordingly, attached hereto is an Order to reinstate the subject license condition as a requirement of your license. Please note that the Order has been made immediately effective pursuant to 10 CFR 2.204. Therefore, any request for hearing on your part will not void the implementation requirements contained in the license condition.

The Commission is aware of existing litigation by the American Mining Congress and several licensees regarding 40 CFR 192. However, the Commission has stated in this instance and other previous similar circumstances that pending litigation is not a basis for the Commission to set aside the implementation of a standard which has been fully promulgated and is in effect. Until such time as the court rules otherwise the Commission has a statutory responsibility to implement the standard.
