
SUBJECT: NOTICE OF VIOLATION (NRC INVESTIGATION REPORT NO. 4-95-056)

Dear Mr. Harris:

On October 22, 1996, the NRC issued a Notice of Violation to you based on the NRC's conclusion that you had violated 10 CFR 50.5, the NRC's rule prohibiting deliberate misconduct. Our records show that our letter, which was sent by certified mail, was received. Although you were required to respond within 30 days, the NRC has no record of receiving a response from you.

Thus, the NRC considers its enforcement action in this matter final and will, as discussed in our October 22 letter to you, place a copy of that correspondence in the NRC's Public Document Room (PDR) and send a copy to your former employer. In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, records or documents compiled for enforcement purposes are placed in the PDR. A copy of this letter with your address removed also will be placed in the PDR.
