

APPLICATION AND AFFIDAVIT

I, J. H. Winso, do hereby depose:

1. I am a management official of GA Technologies Inc. (GA) and am authorized to execute this Application and Affidavit.
2. The attached document entitled:

GA Doc. E-115-1243 Rev. 2, "Reliability Analysis Report"

is treated as proprietary in accordance with the policies of GA and is handled and protected accordingly by GA.
3. This document contains information of a proprietary and confidential nature and is of the type customarily held in confidence by GA and not made available to the public. I am aware that other companies regard information of the kind contained in this document as being proprietary and confidential.
4. This document contains information (including formulas, patterns, compilations, programs, devices, methods, techniques or processes) that derives independent economic value from not being generally known to the public or to other persons who can obtain economic value from its disclosure or use. GA exerts efforts to maintain the secrecy of the information in the documents by controlling access, by entrusting copies only under written confidentiality agreements which forbid further disclosure and limit use by customers, and by withholding copies even from GA's libraries, all of which are reasonable efforts under the circumstances. Accordingly, the information is trade secret within the meaning of California Civil Code Section 3426.1 and is therefore property.
5. GA Technologies Inc. is allowing the attached document to be forwarded by Bechtel Energy Corporation to the Nuclear Regulatory Commission and is requesting that this document be withheld from disclosure per 10 CFR 2.790(a)(4). Further, in response to 10 CFR 2.790(b)(4):

This document has been made available to others outside of GA only as required for conducting business and under suitable agreements providing for non-disclosure and limited use of the information.

 - (c) This document is not readily available through public or private sources.

- (d) This document contains information (of a kind customarily withheld from others as a form of property) generated by GA Technologies Inc. at an expense that was incurred for the benefit of GA.
