The purpose of this modification is to require the contractor to obtain Maryland vehicle tags for each vehicle. Therefore, make the following changes:

- Contractor shall obtain Maryland vehicle tags for each of the ten leased vehicles. He shall provide these tags to the NRC.
- Article X - Marking of Vehicles, in paragraph d. the first sentence is revised to read as follows, "The NRC shall install Maryland vehicle tags on each vehicle."
- Contractor shall be paid the amount of \$5,499.00 for obtaining the Maryland vehicle tags.
