AMENDMENT TO INDEMNITY AGREEMENT NO. B-66  
AMENDMENT NO. 8

Effective January 1, 1984, Indemnity Agreement No. B-66, between Sacramento Municipal Utilities District, and the Atomic Energy Commission, dated March 1, 1973, are amended as follows:

Item 4 of the Attachment to the indemnity agreement is deleted in its entirety and the following substituted therefor:

Item 4 - Location

All of the premises including the land and all buildings and structures known as the Rancho Seco Nuclear Generating Station and the Photovaltaic Project (SMUD PV1) situated on a site of approximately 2500 acres wholly owned and controlled by the Sacramento Municipal Utility District located in Sacramento County, California approximately twenty-five (25) miles southeast of the city of Sacramento, California and approximately twenty-six (26) miles northeast of Stockton, California.
